# A MIXED-LAGRANGE MULTIPLIER FINITE ELEMENT METHOD FOR THE POLYHARMONIC EQUATION (*)

#### Abstract

A finite element method requiring only $C^{0}$ elements is developed for the approximation of the first boundary value problem for the polyharmonic equation, based on the reformulation of this problem as a system of second order equations. The resulting linear system of equations can be easily preconditioned and efficiently solved by the conjugate-gradient method.


Keywords : Mixed methods, Error estimates, Polyharmonic equation.


#### Abstract

Résumé. - Une méthode d'éléments finis qui exige seulement des éléments $C^{0}$, est développée ici, en vue de l'approximation du premier problème aux limites pour l'équation polyharmonique; cette méthode est basée sur une reformulation du problème comme un système d'équations du second ordre. Le système linéaire, ainsi obtenu peut être facilement préconditionné et efficacement résolu par la méthode du gradient conjugué.


## 1. INTRODUCTION

In this paper we wish to consider the approximation by finite elements of the first boundary value problem for the polyharmonic equation, i.e., for an integer $p \geqslant 2$, we seek a solution of

where $\Omega$ is a bounded domain in $R^{2}$ with smooth boundary $\Gamma$ and $[s]$ denotes the greatest integer contained in $s$.

The approach we take will involve a combination of the techniques of

[^0]Lagrange multiplier and mixed methods. In following this approach we will use many of the ideas formulated in Bramble [4] for analyzing the Lagrange multiplier method for the second order Dirichlet problem introduced by Babuška [2]. In terms of the use of mixed methods, the formulation will most closely resemble that given in Falk [11] for the biharmonic problem, although the method of proof will be that of [4].

For the case of the biharmonic problem (i.e., $p=2$ ) we also note the work of Ciarlet and Raviart [9] and Ciarlet and Glowinski [10]. Further ideas in this direction for the Stokes and biharmonic problems can be found in Glowinski and Pirroneau [12]. The techniques of this paper have also been used previously by the present authors to analyze two mixed finite element methods for the simply supported plate problem [5] and by Bramble and Pasciak [7] to study a method for computing the linearized scalar potential for the magnetostatic field problem.

The basic ideas in the approach taken can be described as follows. By the mixed method technique of introducing new dependent variables for appropriate derivatives, we are able to reformulate the problem as a lower order system of equations so that a conforming finite element method can be used with only continuous finite elements. Following [4] we show how the linear system of equations resulting from the Galerkin method applied to the reformulated problem can be easily preconditioned and efficiently solved by the conjugate gradient method. In order to do this, we first introduce appropriate Lagrange multipliers so that the iteration scheme produced will involve only a sequence of second order boundary value problems with natural boundary conditions. Thus a code which implements the Lagrange multiplier method for the second order Dirichlet problem will, with minor modifications, be able to solve the first boundary value problem for the polyharmonic equation.

The approximation scheme we develop is based on the following variational formulation of (1.1)-(1.3).

Let $\vec{w}=\left(w_{0}, \ldots, w_{p-1}\right)$ and $\vec{\sigma}=\left(\sigma_{1}, \ldots, \sigma_{[(p+1) / 2]}\right)$.
Problem $(P)$ : Find $\vec{w}, \vec{\sigma} \in\left(H^{1}(\Omega)\right)^{p} \times\left(H^{-1 / 2}(\Gamma)\right)^{[(p+1) / 2]}$ such that

where (.,.) and $\langle.,$.$\rangle denote the L_{2}$ inner product on $\Omega$ and $\Gamma$ respectively, and $A_{\alpha}(u, v)=(\nabla u, \nabla u)+\alpha\langle u, v\rangle$ with $\alpha>0$ constant.

To understand the relation between Problem ( $P$ ) and the polyharmonic problem (1.1)-(1.3) observe that equations (1.5)-(1.6) imply that

and (1.4) implies $\Delta w_{j-1}=f$. Hence $w_{j}=\Delta^{j} w_{0}$ and so

Condition (1.7) then implies $\Delta^{j} w_{0}=0$ on $\Gamma$ for $j=0,1, \ldots,[(p-1) / 2]$. From (1.6) we also have that

The purpose of this paper is to introduce and analyze a finite element method based on this variational formulation. This will include both the derivation of error estimates for such a scheme (Section 5) and a discussion of an efficient iteration method for its implementation (Section 6). Preceding these results we shall, in Section 2, present some notation and state some a priori estimates for the continuous problem. In Section 3 we define the approximating subspaces to be used in the finite element method and collect some results on the approximation properties of these spaces. Section 4 then contains the description of the approximation scheme along with some additional estimates, the discrete analogues of those in Section 2.

## 2. NOTATION AND PRELIMINARY RESULTS

For $s \geqslant 0$ let $H^{s}(\Omega)$ and $H^{s}(\Gamma)$ denote the Sobolev spaces of order $s$ of functions on $\Omega$ and $\Gamma$ respectively, with associated norms $\|\cdot\|_{s}$ and $|\cdot|_{s}$ respectively ( $c f$. [13]). For $s<0$, let $H^{s}(\Omega)$ and $H^{s}(\Gamma)$ be the respective duals of $H^{-s}(\Omega)$ and $H^{-s}(\Gamma)$, with the usual dual norm.

To simplify the exposition of this paper we shall also use the norm ||| . $\mid \|_{s}$ defined on functions in $H^{s}(\Omega)$ with traces in $H^{s-1 / 2}(\Gamma)$ by $\left\|\|\phi\|_{s}=\right\| \phi \|_{s}+$ $|\phi|_{s-1 / 2}$ and the vector norm

In order to analyze Problem $(P)$ and its finite element approximation, it will also be convenient to introduce the following notation.

Define operators

We then have the following estimates (cf. [5] and [14]).
Lemma 2.1 : There exists a constant $C$ independent of $\sigma$ and $f$ such that for all real $s$

Since we will be working mostly with the bilinear forms we note that $\left\{w_{i}(\vec{\sigma})\right\}$ satisfy for all $v \in H^{1}(\Omega)$ the following variational equations :

In terms of this notation it is then possible to restate Problem $P$ in the form :

where $w_{i}(\vec{\sigma})$ is defined by (2.4).
As in [4] and [5], it will be from this point of view that we will approximate $u$, i.e. we will approximate $G, T$, and $\vec{\sigma}$ to obtain an approximation to $u$.

In this section we wish to prove several a priori estimates relating the functions $\vec{\sigma}$ and $w_{i}(\vec{\sigma})$. To do so we first state some Green's formulas and standard a priori estimates for solutions of the polyharmonic equation $\Delta^{p} z=0$.

Using the Green's formula

we easily obtain for any $1 \leqslant j \leqslant p$ that

Hence for any $1 \leqslant j \leqslant p$

Using (2.16) we can immediately obtain the following equalities.
Choosing $j=p / 2$ we get for $p$ even and all $z \in H^{p}(\Omega)$ with $\Delta^{p} z=0$ that

Choosing $j=(p-1) / 2$ we get for $p$ odd and all $z \in H^{p+1}(\Omega)$ with $\Delta^{p} z=0$ that

& \left.-\left\langle\left(\frac{\partial}{\partial n}+\alpha\right) \Delta^{p-i} z, \Delta^{i-1} v\right\rangle\right\}
\end{aligned}

& =-\left(\Delta^{(p+1) / 2} z, \Delta^{(p-1) / 2} v\right)+\left\langle\left(\frac{\partial}{\partial n}+\alpha\right) \Delta^{(p-1) / 2} z, \Delta^{(p-1) / 2} v\right\rangle
\end{aligned}
$$

we further obtain for $p$ odd and all $z \in H^{p}(\Omega)$ with $\Delta^{p} z=0$ that

&\left.-\left\langle\Delta^{p-i} z,\left(\frac{\partial}{\partial n}+\alpha\right) \Delta^{i-1} v\right\rangle\right\} \cdot(2.18) \tag{2.18}
\end{align*}

Choosing $j=p$ we get for all $z$ satisfying $\Delta^{p} z=0$ and all $v$ satisfying $\Delta^{p} v=0$ that

we get for all $v$ satisfying $\Delta^{p} v=0$ that

Replacing $p-i$ by $i-1$ in the right hand sum, we get for all $v$ satisfying $\Delta^{p} v=0$ that

We now derive another result relating $\vec{\sigma}$ and $w_{i}(\vec{\sigma})$.

## Lemma 2.2 :

& =A_{\alpha}\left(w_{(p-1) / 2}(\vec{\sigma}), w_{(p-1) / 2}(\vec{\sigma})\right) .
\end{aligned}
$$

We shall also require the following a priori estimate satisfied by solutions of the polyharmonic equation ( $c f .[14]$ ).

Lemma 2.3: Let $z$ be a solution of the polyharmonic equation $\Delta^{p} z=0$ in $\Omega$. Then there exists a constant $C$ independent of $z$ such that for all real $s$

\|z\|_{s} \leqslant C\left(\sum_{j=0}^{\left[\frac{p-1}{2}\right]}\left|\Delta^{j} z\right|_{s-2 j-1 / 2}+\sum_{j=1}^{\left[\frac{p-2}{2}\right]}\left|\frac{\partial}{\partial n} \Delta^{j} z\right|_{s-3 / 2-2 j}\right)
$$

Ũsing these resuits we now estabiish two further a priori estimates which are the basis for our error analysis.

Lemma 2.4 : There exist positive constants $C_{0}$ and $C_{1}$ such that

$$

Proof : For $1 \leqslant j \leqslant[(p+1) / 2]$ with $j$ fixed, let $v$ be the solution of the boundary value problem $\Delta^{p} v=0$ in $\Omega$,

\begin{aligned}
\left(\frac{\partial}{\partial n}+\alpha\right) \Delta^{i-1} v & =0, \quad i=1, \ldots,[p / 2] \\
\Delta^{i-1} v & =0, \quad i=1,2, \ldots,[(p+1) / 2], \quad i \neq j \\
\Delta^{j-1} v & =\psi, \quad \text { on } \quad \Gamma .
\end{aligned}
$$

Using (2.17) and (2.18) with $z=w_{0}(\vec{\sigma})$ and recalling (2.13) that $\sigma_{j}=\left(\frac{\partial}{\partial n}+\alpha\right) \Delta^{p-j_{0}}(\vec{\sigma}), j=1,2, \ldots,[(p+1) / 2]$, we get that

\left\langle\sigma_{j}, \psi\right\rangle= \begin{cases}-\left(\Delta^{p / 2} w_{0}(\vec{\sigma}), \Delta^{p / 2} v\right), & p \text { even } \\ A_{\alpha}\left(\Delta^{(p-1) / 2} w_{0}(\vec{\sigma}), \Delta^{(p-1) / 2} v\right), & p \text { odd }\end{cases}
$$

Hence
$\left|\left\langle\sigma_{j}, \psi\right\rangle\right| \leqslant\left\{\begin{array}{lr}\left\|\Delta^{p / 2} w_{0}(\vec{\sigma})\right\|_{0}\left\|\Delta^{p / 2} v\right\|_{0} & p \text { even } \\ A_{\alpha}^{1 / 2}\left(\Delta^{(p-1) / 2} w_{0}(\vec{\sigma}), \Delta^{(p-1) / 2} w_{0}(\vec{\sigma})\right) A_{\alpha}^{1 / 2}\left(\Delta^{(p-1) / 2} v, \Delta^{(p-1) / 2} v\right), \\ p \text { odd } .\end{array}\right.$
Applying Lemma (2.2) we get in either case that

\begin{aligned}
\left|\left\langle\sigma_{j}, \psi\right\rangle\right| & \leqslant\|v\|_{p}\left|\sum_{i=1}^{\left[\frac{p+1}{2}\right.}\left\langle\sigma_{i}, w_{i-1}(\vec{\sigma})\right\rangle\right|^{1 / 2} \\
& \leqslant C\left|\sum_{i=1}^{\left[\frac{p+1}{2}\right]}\left\langle\sigma_{i}, w_{i-1}(\vec{\sigma})\right\rangle\right|^{1 / 2}|\psi|_{p-1 / 2-2(j-1)}
\end{aligned}
$$

(using Lemma (2.3)).
Hence

$$
\begin{aligned}
\left|\sigma_{j}\right|_{1 / 2-p+2(j-1)} & =\sup _{\psi \in H^{p-1 / 2-2(j-1)(\mathrm{C})}} \frac{\left|\left\langle\sigma_{j}, \psi\right\rangle\right|}{|\psi|_{p-1 / 2-2(j-1)}} \\
& \leqslant C\left|\sum_{i=1}^{\left[\frac{p+1}{2}\right]}\left\langle\sigma_{i}, w_{i-1}(\vec{\sigma})\right\rangle\right|^{1 / 2} .
\end{aligned}
$$

Summing from $j=1, \ldots,[(p+1) / 2]$ gives the first inequality.
To get the second inequality, we use Lemma (2.2) and some simple estimates to see that

$$
\left|\sum_{i=1}^{\left[\frac{p+1}{2}\right]}\left\langle\sigma_{i}, w_{i-1}(\vec{\sigma})\right\rangle\right| \leqslant C\left\|w_{0}(\vec{\sigma})\right\|_{p}^{2} .
$$

Now using (2.7) and Lemma (2.1) we have

\left\|w_{0}(\vec{\sigma})\right\|_{p} & \leqslant \sum_{j=1}^{\left[\frac{p+1}{2}\right]}\left\|T^{p-j} G \sigma_{j}\right\|_{p} \leqslant C \sum_{j=1}^{\left[\frac{p+1}{2}\right]}\left|\sigma_{j}\right|_{p-2(p-j)-3 / 2} \\
& =C \sum_{j=1}^{\left[\frac{p+1}{2}\right]}\left|\sigma_{j}\right|_{1 / 2-p+2(j-1)} .
\end{aligned}
$$

Lemma 2.5 : There exist positive constants $C_{0}$ and $C_{1}$ such that

$$
\begin{aligned}
C_{0}|\vec{\sigma}|_{s+1 / 2-2 p} & \leqslant \sum_{j=1}^{\left[\frac{p-1}{2}\right]}\left|w_{i}(\vec{\sigma})\right|_{s-1 / 2-2 i} \\
& \leqslant C_{1}|\vec{\sigma}|_{s+1 / 2-2 p}
\end{aligned}
$$

for all real s.
Proof: Since $\sigma_{j}=\left(\frac{\partial}{\partial n}+\alpha\right) \Delta^{p-j_{w_{0}}}(\vec{\sigma})$ we have for $s>0$ that

\left|\sigma_{j}\right|_{s+2(j-1)} & =\left|\left(\frac{\partial}{\partial n}+\alpha\right) \Delta^{p-j_{w_{0}}}(\vec{\sigma})\right|_{s+2(j-1)} \\
& \leqslant C\left\|\Delta^{p-j_{w}}(\vec{\sigma})\right\|_{s+3 / 2+2(j-1)} \quad \text { (by the trace theorem) } \\
& \leqslant C\left\|w_{0}(\vec{\sigma})\right\|_{s+3 / 2+2(p-1)} \\
& \leqslant C \sum_{i=0}^{\left[\frac{p-1}{2}\right]}\left|w_{i}(\vec{\sigma})\right|_{s+3 / 2+2(p-1)-1 / 2-2 i} \quad \text { (by Lemma }(2  \tag{2.3}\\
& \leqslant C \sum_{i=0}^{\left[\frac{p-1}{2}\right]}\left|w_{i}(\vec{\sigma})\right|_{s+2(p-i)-1}
\end{align*}
$$

Hence

$$
\begin{equation*}
|\vec{\sigma}|_{s} \leqslant C \sum_{i=0}^{\left[\frac{p-1}{2}\right]}\left|w_{i}(\vec{\sigma})\right|_{s+2(p-i)-1} \tag{2.21}
\end{equation*}
$$

For $s=1 / 2-p$ we have by Lemma (2.4) that

\begin{aligned}
|\vec{\sigma}|_{1 / 2-p}^{2} & \leqslant C \sum_{i=1}^{\left[\frac{p+1}{2}\right]}\left\langle\sigma_{i}, w_{i-1}(\vec{\sigma})\right\rangle \\
& \leqslant C \sum_{i=1}^{\left[\frac{p+1}{2}\right]}\left|\sigma_{i}\right|_{1 / 2-p+2(i-1)}\left|w_{i-1}(\vec{\sigma})\right|_{p-1 / 2-2(i-1)} \\
& \leqslant C|\vec{\sigma}|_{1 / 2-p} \sum_{i=0}^{\left[\frac{p-1}{2}\right]}\left|w_{i}(\vec{\sigma})\right|_{p-1 / 2-2 i} \\
& \leqslant C|\vec{\sigma}|_{1 / 2-p} \sum_{i=0}^{\left[\frac{p-1}{2}\right]}\left|w_{i}(\vec{\sigma})\right|_{1 / 2-p+2(p-i)-1}
\end{aligned}
$$

Hence (2.21) also holds for $s=1 / 2-p$. By interpolation, (2.21) holds for $s \geqslant 1 / 2-p$.

For $s<1 / 2-p$ we observe that $s+2(j-1)<-1 / 2, j=1,2, \ldots$,
$[(p+1) / 2]$. Using Green's identity (2.20) we get for all $v$ with $\Delta^{p} v=0$ that

\sum_{i=1}^{\left.\frac{p+1}{2}\right]}\left\langle\sigma_{i}, \Delta^{i-1} v\right\rangle=\sum_{i=1}^{p}\left\langle\Delta^{i-1} w_{0}(\vec{\sigma}),\left(\frac{\partial}{\partial n}+\alpha\right) \Delta^{p-i} v\right\rangle \tag{2.22}
\end{equation*}
$$

Now let $v$ satisfy the boundary conditions

$$
\begin{array}{rlrl}
\left(\frac{\partial}{\partial n}+\alpha\right) \Delta^{i-1} v & =0, & & i=1,2, \ldots,[p / 2] \\
\Delta^{i-1} v & =0, & i_{0}=1,2, \ldots,[(p+1) / 2], \quad i \neq j \\
\Delta^{j-1} v & =\psi & &
\end{array}
$$

Then (2.22) becomes

$$
\begin{aligned}
\left\langle\sigma_{j}, \psi\right\rangle & =\left[\frac{\left[\frac{p+1}{2}\right]}{\sum_{i=1}}\left\langle\Delta^{i-1} w_{0}(\vec{\sigma}),\left(\frac{\partial}{\partial n}+\alpha\right) \Delta^{p-i} v\right\rangle\right. \\
& \leqslant \sum_{i=1}^{\left[\frac{p+1}{2}\right]}\left|w_{i-1}(\vec{\sigma})\right|_{s+2(p-i+1)-1}\left|\left(\frac{\partial}{\partial n}+\alpha\right) \Delta^{p-i} v\right|_{-s-2(p-i+1)+1}
\end{aligned}
$$

Now for $s<1 / 2-p$
$-s-2(p-i+1)+1>p-1 / 2-2 p+2(i-1)+1=1 / 2-p+2(i-1)$.
Hence from the preceeding results we have that
$\left|\left(\frac{\partial}{\partial n}+\alpha\right) \Delta^{p-i} v\right|_{-s-2(p-i+1)+1}=\left|\left(\frac{\partial}{\partial n}+\alpha\right) \Delta^{p-i} v\right|_{-s-2 p+1+2(i-1)}$
$\leqslant C \sum_{i=0}^{\left[\frac{p-1}{2}\right]}\left|\Delta^{i} v\right|_{-s-2 p+1+2(p-i)-1}=C \sum_{i=0}^{\left[\frac{p-1}{2}\right]}\left|\Delta^{i} v\right|_{-s-2 i} \leqslant C|\psi|_{-s-2(j-1)}$.
Then

$$
\begin{aligned}
\left|\sigma_{j}\right|_{s+2(j-1)} & =\sup _{\psi \in H^{-s-2(j-1)(\Gamma)}} \frac{\left\langle\sigma_{j}, \psi\right\rangle}{|\psi|_{-s-2(j-1)}} \\
& \leqslant C \sum_{i=1}^{\left[\frac{p+1}{2}\right]}\left|w_{i-1}(\vec{\sigma})\right|_{s+2(p-i+1)-1} \\
& =C \sum_{i=0}^{\left[\frac{p-1}{2}\right]}\left|w_{i}(\vec{\sigma})\right|_{s+2(p-i)-1}
\end{aligned}
$$

Summing from $j=1, \ldots,[(p+1) / 2]$ gives (2.21) for $s<1 / 2-p$. The left hand inequality follows by replacing $s$ by $s+1 / 2-2 p$.

To prove the right hand inequality we have from (2.7) that

\left|w_{i}(\vec{\sigma})\right|_{s-1 / 2-2 i} \leqslant \sum_{j=1}^{m}\left|T^{p-i-j} G \sigma_{j}\right|_{s-1 / 2-2 i} .
$$

Now for $i+j<p$, we have by Lemma (2.1) that

\left|T^{p-i-j} G \sigma_{j}\right|_{s-1 / 2-2 i} & \leqslant C\left\|T^{p-i-j-1} G \sigma_{j}\right\|_{s-2-2 i} \\
& \leqslant C\left\|G \sigma_{j}\right\|_{s-2-2 i-2(p-i-j-1)} \\
& \leqslant C\left|\sigma_{j}\right|_{s-2(p-j)-3 / 2} \\
& =C\left|\sigma_{j}\right|_{s+1 / 2-2 p+2(j-1)}
\end{aligned}
$$

and for $i+j=p$ that

$$
\begin{aligned}
\left|T^{p-i-j} G \sigma_{j}\right|_{s-1 / 2-2 i} & \leqslant C\left|\sigma_{j}\right|_{s-1 / 2-2 i-1} \\
& =C\left|\sigma_{j}\right|_{s+1 / 2-2 p+2(j-1)}
\end{aligned}
$$

Hence

$$
\begin{aligned}
\sum_{i=0}^{\left[\frac{p-1}{2}\right]}\left|w_{i}(\vec{\sigma})\right|_{s-1 / 2-2 i} & \leqslant C \sum_{j=1}^{m}\left|\sigma_{j}\right|_{s+1 / 2-2 p+2(j-1)} \\
& \leqslant C|\vec{\sigma}|_{s+1 / 2-2 p} .
\end{aligned}
$$

## 3. APPROXIMATING SPACES ON $\Omega$ AND $\Gamma$

For $0<h<1$, let $\left\{S_{h}\right\}$ be a family of finite dimensional subspaces of $H^{1}(\Omega)$ and $V_{h}=\left\{\vec{w}_{h}: w_{h, i} \in S_{h}, i=0,1, \ldots, p-1\right\}$. Let $r \geqslant 2$ be an integer. We shall assume that for $\phi \in H^{l}(\Omega)$, with $1 \leqslant l \leqslant r$, there is a constant $C$ such that

$$
\begin{equation*}
\inf _{x \in S_{h}}\|\phi-\chi\|_{j} \leqslant \mathrm{Ch}^{l-j}\|\phi\|_{l}, \quad j \leqslant 1 . \tag{3.1}
\end{equation*}
$$

We now define operators $G_{h}: H^{-1 / 2}(\Gamma) \rightarrow S_{h}$ and $T_{h}: H^{-1}(\Omega) \rightarrow S_{h}$ by

$$
A_{\alpha}\left(G_{h} \theta, \chi\right)=\langle\theta, \chi\rangle \quad \forall \chi \in S_{h}
$$

and

$$
A_{a}\left(T_{h} f, \chi\right)=(f, \chi) \quad \forall \chi \in S_{h}
$$

These are just the standard Ritz-Galerkin approximations to $G$ and $T$.
It follows from the approximation assumptions and standard duality arguments that we have the following well known results (cf. [3] and [6]).

Lemma 3.1 : There exists a constant $C$ independent of $\sigma, f$, and $h$ such that

$$
\left|\left(G-G_{h}\right) \sigma\right|_{j-1 / 2}+\left\|\left(G-G_{h}\right) \sigma\right\|_{j} \leqslant C h^{l-j}\|G \sigma\|_{l}
$$

and

$$
\left|\left(T-T_{h}\right) f\right|_{j-1 / 2}+\left\|\left(T-T_{h}\right) f\right\|_{j} \leqslant C h^{l-j}\|T f\|_{l}
$$

for $2-r \leqslant j \leqslant 1 \leqslant l \leqslant r, \sigma \in H^{l-3 / 2}(\Gamma)$, and $f \in H^{l-2}(\Omega)$.
Note that the restriction to $\Omega$ of continuous piecewise polynomials of degree $r-1$ on a quasi-uniform triangulation of $R^{2}$ or a rectangular mesh of width $h$ are examples of spaces $S_{h}$ satisfying Lemma (3.1)

In the analysis in the subsequent sections we shall require additional estimates for the approximation of the operators $T$ and $G$ by $T_{h}$ and $G_{h}$. These are contained in the following theorems.

Theorem 3.1: There exists a constant $C$ independent of $h$ and $f$ such that for integer $l \geqslant 1$ and $f \in H^{t}(\Omega)$

$$
\left|\left(T^{l}-T_{h}^{l}\right) f\right|_{j-1 / 2}+\left\|\left(T^{l}-T_{h}^{l}\right) f\right\|_{j} \leqslant C h^{t+2 l+\min (r-2 l .-j)}\|f\|_{t}
$$

for all $-1 \leqslant t \leqslant \max (r-2 l,-j)$ and all $2-r \leqslant j \leqslant 1$.
Proof: The case $l=1$ is Lemma (3.1). We now prove the general result by induction on $l$. Assuming the result holds for some integer $l \geqslant 1$, we write

$$
T^{l+1}-T_{h}^{l+1}=T^{l}\left(T-T_{h}\right)+\left(T^{l}-T_{h}^{l}\right)\left(T_{h}-T\right)+\left(T^{l}-T_{h}^{l}\right) T
$$

Then

$$
\begin{aligned}
\left\|T^{l}\left(T-T_{h}\right) f\right\|_{j} \leqslant C\left\|\left(T-T_{h}\right) f\right\|_{j-2 l} & \leqslant C h^{\min (r-2,2 l-j)+t+2}\|f\|_{t} \\
& \leqslant C h^{t+2(l+1)+\min (r-2(l+1),-j)}\|f\|_{t}
\end{aligned}
$$

for all $-1 \leqslant t \leqslant r-2$, by Lemma (3.1).
By the induction hypothesis, we have for all $-1 \leqslant \tilde{t} \leqslant \max (r-2 l,-j)$ that

$$
\begin{aligned}
\left\|\left(T^{l}-T_{h}^{l}\right) T f\right\|_{j} & \leqslant C h^{\tilde{t}+2 l+\min (r-2 l,-j)}\|T f\|_{\tilde{t}} \\
& \leqslant C h^{\tilde{t}+2 l+\min (r-2 l,-j)}\|f\|_{\tilde{t}-2} .
\end{aligned}
$$

vol. $19, n^{\circ} 4,1985$

We now consider three cases :
(i) If $j \geqslant 2 l+2-r$, we get for $-1 \leqslant t \leqslant \max (r-2(l+1),-j)=$ $r-2 l-2$ and $\tilde{t}=t+2$ that

$$
\begin{aligned}
\left\|\left(T^{l}-T_{h}^{l}\right) T f\right\|_{j} & \leqslant C h^{t+2(l+1)+\min (r-2 l,-j)}\|f\|_{t} \\
& \leqslant C h^{t+2(l+1)+\min (r-2(l+1),-j)}\|f\|_{t}
\end{aligned}
$$

(ii) If $2-r \leqslant j \leqslant 2 l-r$, we get for $-1 \leqslant t \leqslant \max (r-2(l+1),-j)=$ $-j$ and $\tilde{t}=t$ that

$$
\begin{aligned}
\left\|\left(T^{l}-T_{h}^{l}\right) T f\right\|_{j} & \leqslant C h^{t+2 l+\min (r-2 l,-j)}\|f\|_{t-2} \\
& \leqslant C h^{t+2(l+1)+r-2(l+1)}\|f\|_{t-2} \\
& \leqslant C h^{t+2(l+1)+\min (r-2(l+1),-j)}\|f\|_{t} .
\end{aligned}
$$

(iii) If $2 l-r<j<2 l+2-r$, we get for $-1 \leqslant t \leqslant \max (r-2(l+1)$, $-j)=-j$ and $\tilde{t}=t+r-2 l+j$ that

$$
\begin{aligned}
\left\|\left(T^{l}-T_{h}^{l}\right) T f\right\|_{j} & \leqslant C h^{t+r-2 l+j+2 l+\min (r-2 l,-j)}\|f\|_{i-2} \\
& \leqslant C h^{t+r}\|f\|_{t} \\
& \leqslant C h^{t+2(l+1)+\min (r-2(l+1),-j)}\|f\|_{t}
\end{aligned}
$$

where we have observed that for $t$ in the above range,

$$
-1+r-2 l+j \leqslant \tilde{t} \leqslant-j+r-2 l+j=r-2 l \leqslant \max (-j, r-2 l)
$$

To estimate the remaining term, we again use the induction hypothesis to see that for $-1 \leqslant t \leqslant r-2$ and $r \geqslant 3$

$$
\begin{aligned}
\left\|\left(T^{l}-T_{h}^{l}\right)\left(T_{h}-T\right) f\right\|_{j} & \leqslant C h^{-1+2 l+\min (r-2 l,-j)}\left\|\left(T_{h}-T\right) f\right\|_{-1} \\
& \leqslant C h^{-1+2 l+\min (r-2 l,-j)+t+3}\|f\|_{t} \\
& \leqslant C h^{t+2(l+1)+\min (r-2(l+1),-j)}\|f\|_{t} .
\end{aligned}
$$

To complete the lemma we need only consider this last term in the case $r=2$ and $0 \leqslant j \leqslant 1$. Using the induction hypothesis we have for $-1 \leqslant t \leqslant 0$ that

$$
\begin{aligned}
\left\|\left(T^{l}-T_{h}^{l}\right)\left(T_{h}-T\right) f\right\|_{j} & \leqslant C h^{-j+2 l+\min (2-2 l,-j)}\left\|\left(T_{h}-T\right) f\right\|_{-j} \\
& \leqslant C h^{2 l-j+\min (2-2 l,-j)+t+2}\|f\|_{t} \\
& \leqslant C h^{t+2(l+1)+\min (2-2 l,-j)-j}\|f\|_{t} \\
& \leqslant C h^{t+2(l+1)+\min (2-2(l+1),-j)}\|f\|_{t}
\end{aligned}
$$

The last inequality follows since $0 \leqslant j \leqslant 1$ and

$$
\min (2-2 l,-j)-j= \begin{cases}-2 j, & l=1 \\ 2-2 l-j, & l \geqslant 2\end{cases}
$$

and

$$
\min (2-2(l+1),-j)= \begin{cases}-2, & l=1 \\ 2-2 l-2, & l \geqslant 2\end{cases}
$$

The theorem now follows by combining these results.
The following is an important special case of the theorem which we shall frequently use.

Corollary 3.1:

$$
\left|\left(T^{l}-T_{h}^{l}\right) f\right|_{j-1 / 2}+\left\|\left(T^{l}-T_{h}^{l}\right) f\right\|_{j} \leqslant C h^{t+2 l-j}\|f\|_{t}
$$

for all $2 l-r \leqslant j \leqslant 1$ and $-1 \leqslant t \leqslant r-2 l$.
In an exactly analogous manner one can show the following.
Theorem 3.2 : There exists a constant $C$ independent of $h$ and $\sigma$ such that for integer $l \geqslant 1$ and $\sigma \in H^{t+1 / 2}(\Gamma)$

$$
\begin{aligned}
\left|T^{l-1} G \sigma-T_{h}^{l-1} G_{h} \sigma\right|_{j-1 / 2}+\| T^{l-1} G \sigma- & T_{h}^{l-1} G_{h} \sigma \|_{j} \\
& \leqslant C h^{t+2 l+\min (r-2 l,-j)}|\sigma|_{t+1 / 2}
\end{aligned}
$$

for all $-1 \leqslant t \leqslant \max (r-2 l,-j)$ and all $2-r \leqslant j \leqslant 1$.
Corollary 3.2 :

$$
\begin{aligned}
\left|T^{l-1} G \sigma-T_{h}^{l-1} G_{h} \sigma\right|_{j-1 / 2}+\| T^{l-1} G \sigma-T_{h}^{l-1} G_{h} & \sigma \|_{j} \\
& \leqslant C h^{t+2 l-j}|\sigma|_{t+1 / 2}
\end{aligned}
$$

for $2 l-r \leqslant j \leqslant 1$ and $-1 \leqslant t \leqslant r-2 l$.
For $0<k<1$, we shall let $\left\{\dot{S}_{k}\right\}$ be a family of finite dimensional subspaces of $H^{n}(\Gamma), n \geqslant \max (0,2[(p-1) / 2]-1 / 2)$, and let $\dot{V}_{k}=\left\{\vec{\sigma}: \sigma_{i} \in \dot{S}_{k}, i=0\right.$, $1, \ldots,[(p-1) / 2]\}$. Let $\dot{r} \geqslant 1$ be an integer. We shall suppose that for $\phi \in H^{l}(\Gamma)$ with $j \leqslant n$ and $j \leqslant l \leqslant \dot{r}$, there is a constant $C$ such that

We further assume that for $j \leqslant i \leqslant n$ there is a constant $C$ such that

The conditions (3.2) and (3.3) together imply that for any given $j_{0} \leqslant n$ there is an operator $\Pi_{k}: H^{j_{0}}(\Gamma) \rightarrow \dot{S}_{k}$ with

uniformly in $j$ and $l$ for $j \leqslant n$ and $j_{0} \leqslant j \leqslant l \leqslant \dot{r}$. This result can be found in [8]. Finally, we denote by $P_{0}$ the $L_{2}(\Gamma)$ orthogonal projection onto $\dot{S}_{k}$, i.e. for $\phi \in L_{2}(\Gamma)=H^{0}(\Gamma)$,

&=\left\langle\sigma, P_{0} T_{h}^{m} G_{h} \theta\right\rangle
\end{aligned}
$$

## 4. THE APPROXIMATION SCHEME

We now are ready to define a finite element method for the approximation of the first boundary value problem for the polyharmonic equation, based on the variational formulation of Problem ( $P$ ).

Let $\vec{w}_{h}=\left(w_{h, 0}, \ldots, w_{h, p-1}\right)$ and $\vec{\sigma}_{k}=\left(\sigma_{k, 1}, \ldots, \sigma_{k,[(p+1) / 2]}\right)$.
$\operatorname{Problem}\left(P_{h}^{k}\right):$ Find $\vec{w}_{h}, \vec{\sigma}_{k} \in V_{h} \times \dot{V}_{k}$ such that

A_{\alpha}\left(w_{h, p-1}, v_{h}\right)=-\left(f, v_{h}\right)+\left\langle\sigma_{k, 1}, v_{h}\right\rangle & \forall v_{h} \in S_{h}, \\
A_{\alpha}\left(w_{h, p-j}, v_{h}\right)=-\left(w_{h, p+1-j}, v_{h}\right)+\left\langle\sigma_{k, j}, v_{h}\right\rangle & \forall v_{h} \in S_{h}, \\
& j=2,3, \ldots,[(p+1) / 2], \tag{4.2}
\end{array}
$$

$A_{\alpha}\left(w_{h, j-1}, v_{h}\right)=-\left(w_{h, j}, v_{h}\right)$

$$
\begin{align*}
& \forall v_{h} \in S_{h} \\
& j=1,2, \ldots,[p / 2] \tag{4.3}
\end{align*}
$$

and

$$
\begin{equation*}
\left\langle w_{i, j-1} ; \theta_{k}\right\rangle=0 \quad \forall \theta_{k} \in \dot{S}_{k}, \quad j=1,2, \ldots,[(p+1) / 2] \tag{4.4}
\end{equation*}
$$

Using the operators $T_{h}$ and $G_{h}$ we may also restate Problem $\left(P_{h}^{k}\right)$ in a form analogous to Problem $Q$. From (4.1)-(4.3) we get

We will approximate the functions $w_{j}$ by $w_{h, j}$ (and $u=w_{0}$ by $u_{h}=w_{h, 0}$ ). From (4.5)-(4.7) we get that

Then

w_{h, i}=w_{h, i}\left(\vec{\sigma}_{k}\right)+(-1)^{p-i} T_{h}^{p-i} f, \quad i=0,1, \ldots, p-1 \tag{4.10}
\end{equation*}
$$

In terms of the bilinear forms we note that $\left\{w_{h, i}(\vec{\sigma})\right\}$ satisfy for all $v_{h} \in S_{h}$ the following variational equations.
$A_{\alpha}\left(w_{h, p-1}(\vec{\sigma}), v_{h}\right)=\left\langle\sigma_{1}, v_{h}\right\rangle$
$A_{\alpha}\left(w_{h, p-j}(\vec{\sigma}), v_{h}\right)=-\left(w_{h, p+1-j}(\vec{\sigma}), v_{h}\right) \quad j=2,3, \ldots,[(p+1) / 2]$,
and
$A_{\alpha}\left(w_{h, j-1}(\vec{\sigma}), v_{h}\right)=-\left(w_{h, j}(\vec{\sigma}), v_{h}\right), \quad j=1,2, \ldots,[p / 2]$.
In terms of this notation it is then possible to restate Problem $\left(P_{h}^{k}\right)$ in the form :

Problem $\left(Q_{h}^{k}\right):$ Find $\vec{\sigma}_{k}=\left(\sigma_{k, 1}, \ldots, \sigma_{k,[(p+1) / 2]}\right) \in \dot{V}_{k}$ such that
$P_{0} w_{h, i}(\vec{\sigma})=P_{0}\left\{(-1)^{p-i+1} T_{h}^{p-i} f\right\}, \quad i=0,1, \ldots,[(p-1) / 2]$,
where $w_{h, i}\left(\vec{\sigma}_{k}\right)$ is defined by (4.9).
Our aim is now to study the functions $w_{h, i}(\vec{\sigma})$ and prove estimates analogous to those in Lemmas (2.4) and (2.5).

To simplify the analysis, it will be convenient to first prove the following result.

Lemma 4.1 : Let $w_{i}(\vec{\sigma})$ and $w_{n, i}(\vec{\sigma})$ be defined by $(2,7)$ and (4.9) respectively. Then if $\vec{\sigma} \in \vec{H}^{+1 / 2}(\Gamma)$ we have for $-1 \leqslant t \leqslant 2 i+\max (r-2 p$, $-s-2 i$ ) and $2-r \leqslant s \leqslant 1$ that

We now consider three cases :
(i) $-2 i+2 p-r \leqslant s \leqslant 1,-1 \leqslant t \leqslant 2 i+r-2 p$. Then
$-1 \leqslant t+2(j-1) \leqslant 2 i+r-2 p+2(j-1)$

holds for $i \geqslant 0$ and $j \geqslant 1$. Hence by Theorem(3.1)

& \leqslant \sum_{j=1}^{m} C h^{t+2(p-i)-s}\left|\sigma_{j}\right|_{t+2(j-1)+1 / 2} \\
& \leqslant C h^{t+2(p-i)-s}|\vec{\sigma}|_{t+1 / 2} .
\end{aligned}
$$

(ii) $-1 \leqslant t \leqslant-s$ and $2-r \leqslant s \leqslant 2(p-i-m+1)-r$. Then $-s \geqslant$ $r-2(p-i-j+1)$ for $j=1, \ldots, m$ and we get using Theorem (3.1) that

(iii) $-1 \leqslant t \leqslant-s$ and $2(p-l-i)-r \leqslant s \leqslant 2(p-l-i+1)-r$ where $l=1, \ldots, m-1$. Then by Theorem (3.1), we get for

Choose $t_{j}=t$ for $j=1, \ldots, l$ and $t_{j}=t+s+r-2(p-i-j+1)$ for $j=l+1, \ldots, m$.

Since

and $r+s-2(p-j-i+1) \geqslant 0$ for $j=l+1, \ldots, m$, we observe that for $-1 \leqslant t \leqslant-s$ this choice of $t_{j}$ does give values in the range required by (4.15).

Hence we have

&+\sum_{j=l+1}^{m} C h^{t+r}\left|\sigma_{j}\right|_{t+r+s-2(p-i-j+1)+1 / 2}
\end{aligned}
$$

Now $s \leqslant 2(p-l-i+1)-r$ implies

t+r+s-2(p-i-j+1)+1 / 2 \leqslant t+2(j-1) & +1 / 2+2(1-l) \\
& \leqslant t+2(j-1)+1 / 2
\end{aligned}

Hence $\left|\left|\left|w_{i}(\vec{\sigma})-w_{h, i}(\vec{\sigma})\right| \|_{s} \leqslant C h^{t+r}\right| \vec{\sigma}\right|_{t+1 / 2}$.
Combining these results we see that

C h^{t+2(p-i)-s}|\vec{\sigma}|_{t+1 / 2} & \text { for } & -2 i+2 p-r \leqslant s \leqslant 1 \\
& -1 \leqslant t \leqslant 2 i+r-2 p \\
& & 2-r \leqslant s \leqslant 2 p-r-2 i \\
C h^{t+r}|\vec{\sigma}|_{t+1 / 2} & \text { for } & -1 \leqslant t \leqslant-s
\end{array}\right.
$$

We can further simplify this to the form given in the statement of the lemma, i.e.

Lemma 4.2 : For $-1 \leqslant t \leqslant 2 i+r-2 p$ and $2 p-r \leqslant \tilde{s} \leqslant 1+2 i$

& \leqslant C_{1}|\vec{\sigma}|_{1 / 2-p}^{2}+\left|\sum_{i=1}^{\left[\frac{p+1}{2}\right]}\left\langle\sigma_{i}, w_{i-1}(\vec{\sigma})-w_{h, i-1}(\vec{\sigma})\right\rangle\right| \tag{4.16}
\end{align*}

Now

&\left|\left\langle\sigma_{i}, w_{i-1}(\vec{\sigma})-w_{h, i-1}(\vec{\sigma})\right\rangle\right| \leqslant\left|\vec{\sigma}_{i}\right|_{-1 / 2}\left|w_{i-1}(\vec{\sigma})-w_{h, i-1}(\vec{\sigma})\right|_{1 / 2} \\
& \leqslant\left|\sigma_{i}\right|_{-1 / 2} C h^{-1+2 p-1-2(i-1)}|\vec{\sigma}|_{-1 / 2}
\end{aligned}

(by Lemma (4.1), assuming $r-2 p \geqslant-1$ )
(by (3.3))

The lemma follows for $p \geqslant 2$ and $h \leqslant \varepsilon k$ with $\varepsilon$ sufficiently small.
Lemma 4.4 : There exist positive constants $C_{0}$ and $C_{1}$ independent of $\vec{\sigma}$ and $k$ such that for all $-\dot{r}+2[(p-1) / 2]+1 / 2 \leqslant s \leqslant \min (p, n+1 / 2)$ and all $\vec{\sigma} \in \dot{V}_{k}$,

C_{0}|\vec{\sigma}|_{s+1 / 2-2 p} \leqslant \sum_{i=0}^{\left[\frac{p-1}{2}\right]}\left|P_{0} w_{i}(\vec{\sigma})\right|_{s-1 / 2-2 i} \leqslant C_{1}|\vec{\sigma}|_{s+1 / 2-2 p}
$$

Proof : From Lemma (2.5) and the triangle inequality we have

& \leqslant C_{1}|\vec{\sigma}|_{s+1 / 2-2_{p}}+\sum_{i=0}^{\left[\frac{p-1}{2}\right]}\left|\left(I-P_{0}\right) w_{i}(\vec{\sigma})\right|_{s-1 / 2-2 i}
\end{aligned}
$$

Now for $-\dot{r}+2[(p-1) / 2]+1 / 2 \leqslant s \leqslant n+1 / 2$, and $0 \leqslant i \leqslant[(p-1) / 2]$ we have $-\dot{r} \leqslant s-2 i-1 / 2 \leqslant n$ and so by Lemma (3.2),

Now by (2.7) and Lemma (2.1),

& \leqslant C \sum_{j=1}^{\left[\frac{p+1}{2}\right]}\left\|G \sigma_{j}\right\|_{\bar{\nu}} 2(\bar{p}-j) \leqslant C \sum_{j=1}^{\left[\frac{p+1}{2}\right]}\left|\sigma_{j}\right|_{p-2(p-j)-3 / 2} \\
& \leqslant C \sum_{j=1}^{\left[\frac{p+1}{2}\right]}\left|\sigma_{j}\right|_{1 / 2-p+2(j-1)} \leqslant C|\vec{\sigma}|_{1 / 2-p}
\end{aligned}
$$

Hence from Lemma (2.4) we get for

\left|\left(I-P_{0}\right) w_{i}(\vec{\sigma})\right|_{s-1 / 2-2 i}^{2} & \leqslant C k^{2(p-s)}\left|\sum_{i=1}^{\left[\frac{p+1}{2}\right]}\left\langle\sigma_{i}, w_{i-1}(\vec{\sigma})\right\rangle\right| \\
& \leqslant C k^{2(p-s)} \sum_{i=1}^{\left[\frac{p+1}{2}\right]}\left|\left\langle\sigma_{i}, P_{0} w_{i-1}(\vec{\sigma})\right\rangle\right| \\

## 5. ERROR ESTIMATES

We begin this section by proving a preliminary result.

Theorem 5.1: Let $\vec{\sigma}$ and $\vec{\sigma}_{k}$ be the respective solutions of Problems $Q$ and $Q_{k}^{h}$. If $\max (2 p-1,2 p-n-1 / 2) \leqslant r \leqslant \dot{r}-2[(p-1) / 2]-1 / 2+2 p$ and $h \leqslant \varepsilon k$ with $\varepsilon$ sufficiently small, we have for $\vec{\sigma}$ and $f$ sufficiently smooth that

\left|\vec{\sigma}_{k}-\Pi_{k} \vec{\sigma}\right|_{s+1 / 2-2 p} \leqslant & C h^{2-s}\left(\|f\|_{-s}+|\vec{\sigma}|_{1 / 2-s}\right)+C\left|\vec{\sigma}-\Pi_{k} \vec{\sigma}\right|_{s-2 p+1 / 2} \\
& \quad+\sum_{i=0}^{\left[\frac{p-1}{2}\right]} C k^{\alpha_{i}-s+2 i+1 / 2}\left|\vec{\sigma}-\Pi_{k} \vec{\sigma}\right|_{\alpha_{i}+2 i-2 p+1} \\
\leqslant & C h^{2-s}\left(\|f\|_{-s}+|\vec{\sigma}|_{1 / 2-s}\right)+C k^{t-s+2 p-1 / 2}|\vec{\sigma}|_{t} \\
& -1 / 2 \leqslant t \leqslant \dot{r}+2[(p-1) / 2] \tag{5.7}
\end{align*}
$$

and for $n=0$ (and hence $p=2$ ), $h \leqslant \varepsilon k^{(7-2 s) / 3}$ and $0 \leqslant s \leqslant 1 / 2=\alpha$ that

$$
\begin{align*}
\left|\vec{\sigma}_{k}-\Pi_{k} \vec{\sigma}\right|_{s-7 / 2} \leqslant C h^{2-s}(1+ & \left.(k / h)^{1 / 2-s}\right)\left(\|f\|_{-s}+|\vec{\sigma}|_{1 / 2-s}\right) \\
& +C k^{t+7 / 2-s}|\vec{\sigma}|_{t}, \quad-1 / 2 \leqslant t \leqslant \dot{r} \tag{5.8}
\end{align*}
$$

Now for $\alpha \leqslant s \leqslant 2 p-1$ we have by (3.3) that

$$
\left|\vec{\sigma}_{k}-\Pi_{k} \vec{\sigma}\right|_{s+1 / 2-2 p} \leqslant C k^{\alpha-s}\left|\vec{\sigma}_{k}-\Pi_{k} \vec{\sigma}\right|_{\alpha+1 / 2-2 p}
$$

Now using (5.7) and (5.8) with $s=\alpha$, we get for $n \geqslant 0, h \leqslant \varepsilon k^{2(p-\alpha) /(2-\alpha)}$, and $\alpha \leqslant s \leqslant 2 p-1$ that

$$
\begin{gathered}
\left|\vec{\sigma}_{k}-\Pi_{k} \vec{\sigma}\right|_{s+1 / 2-2 p} \leqslant C k^{\alpha-s}\left(h^{2-\alpha}\|f\|_{-\alpha}+|\vec{\sigma}|_{1 / 2-\alpha}\right) \\
+C k^{t+2 p-s-1 / 2}|\vec{\sigma}|_{t}, \\
-1 / 2 \leqslant t \leqslant \dot{r}-2[(p-1) / 2] .
\end{gathered}
$$

The theorem now follows from (3.4) and the triangle inequality.
Theorem 5.4 : Suppose the hypotheses of Theorem (5.3) are satisfied, and that $w_{i}$ and $w_{h, i}$ are defined by (2.8) and (4.10) respectively (in particular $u=w_{0}$ and $u_{h}=w_{h, 0}$ ). Then for all $\alpha \leqslant s \leqslant 1$ and $h \leqslant \varepsilon k^{2(p-\alpha) /(2-\alpha)}$

$$
\begin{aligned}
\left\|w_{i}-w_{h, i}\right\|_{s}+\left|w_{i}-w_{h, i}\right|_{s-1 / 2} & \leqslant C\left\{h^{2-s}\left(|\vec{\sigma}|_{1 / 2-s}+\|f\|_{-s}\right)\right. \\
& +\left(h^{2-s} k^{s-\alpha}+h^{2-\alpha} k^{\alpha-s-2 i}\right)\left(\|f\|_{-\alpha}+|\vec{\sigma}|_{1 / 2-\alpha}\right) \\
& \left.+k^{\dot{i}-2[(p-1) / 2]-s-2 i+2 p-1 / 2}|\vec{\sigma}|_{\dot{r}-2[(p-1) / 2]}\right\},
\end{aligned}
$$

$i=0,1, \ldots, p-2$.
For $i-\tilde{p}-1$, the estimate holds with $\|f\|_{-s}$ replaced by $\|f\|_{\hat{0}}$.
Proof: From (2.8) and (4.10) we have that

$$
\left\|w_{i}-w_{h, i}\right\|_{s} \leqslant\left\|w_{i}(\vec{\sigma})-w_{h, i}\left(\vec{\sigma}_{k}\right)\right\|_{s}+\left\|T^{p-i} f-T_{h}^{p-i} f\right\|_{s}
$$

From Theorem 3.1 we get for $0 \leqslant s \leqslant 1$ that

$$
\left\|\left\|T^{p-i} f-T_{h}^{p-i} f\right\|_{s} \leqslant \begin{cases}C h^{2-s}\|f\|_{-s}, & i=0,1, \ldots, p-2 \\ C h^{2-s}\|f\|_{0}, & i=p-1 .\end{cases}\right.
$$

From Lemma 5.2 we obtain for $0 \leqslant s \leqslant 1$ that

$$
\begin{aligned}
&\left\|\left.\left|\left|w_{i}(\vec{\sigma})-w_{i}\left(\vec{\sigma}_{k}\right)\right| \|_{s} \leqslant C h^{t+2}\right| \vec{\sigma}\right|_{t+1 / 2}+C h^{\bar{t}+2}\left|\vec{\sigma}-\vec{\sigma}_{k}\right|_{\vec{t}+1 / 2}\right. \\
&+C\left|\vec{\sigma}-\vec{\sigma}_{k}\right|_{s+2 i-2 p+1 / 2}
\end{aligned}
$$

$-1 \leqslant t \leqslant s,-1 \leqslant \bar{t} \leqslant \min (-s, n-1 / 2)$.

Now by (3.3),

$$
\begin{aligned}
&\left|\vec{\sigma}-\vec{\sigma}_{k}\right|_{\bar{t}+1 / 2} \leqslant\left|\vec{\sigma}-\Pi_{k} \vec{\sigma}\right|_{\bar{t}+1 / 2}+C k^{-\bar{t}-p}\left\{\left|\vec{\sigma}-\Pi_{k} \vec{\sigma}\right|_{1 / 2-p}\right. \\
&\left.+\left|\vec{\sigma}-\vec{\sigma}_{k}\right|_{1 / 2-p}\right\}
\end{aligned}
$$

Hence for $0 \leqslant s \leqslant 1$, we get using Theorem 5.3 and choosing $t=-s$ and $\bar{t}=\min (-s, n-1 / 2)$ that

$$
\begin{aligned}
\left|\vec{\sigma}-\vec{\sigma}_{k}\right|_{t+1 / 2} \leqslant C k^{-\bar{t}-\alpha}|\vec{\sigma}|_{1 / 2-\alpha} & +C k^{-\bar{t}-p}\left|\vec{\sigma}-\vec{\sigma}_{k}\right|_{1 / 2-p} \\
\leqslant C k^{-\bar{t}-\alpha}|\vec{\sigma}|_{1 / 2-\alpha} & +C k^{-\bar{t}-p}\left\{h^{2-\alpha} k^{a-p}\left(\|f\|_{-\alpha}+|\vec{\sigma}|_{1 / 2-\alpha}\right)\right. \\
& \left.+k^{p-\alpha}|\vec{\sigma}|_{1 / 2-\alpha}\right\}
\end{aligned}
$$

Hence

$$
\begin{aligned}
& C h^{\bar{t}+2}\left|\vec{\sigma}-\vec{\sigma}_{k}\right|_{\bar{t}+1 / 2} \leqslant C h^{\bar{t}+2}\left\{k^{-\bar{t}-\alpha}|\vec{\sigma}|_{1 / 2-\alpha}\right. \\
&\left.+h^{2-\alpha} k^{\alpha-2 p-\bar{t}}\left(\|f\|_{-\alpha}+|\vec{\sigma}|_{1 / 2-\alpha}\right)\right\} \\
& \leqslant C h^{\bar{t}+2} k^{-\bar{t}-\alpha}\left\{|\vec{\sigma}|_{1 / 2-\alpha}+h^{2-\alpha} k^{2 \alpha-2 p}\left(\|f\|_{-\alpha}\right.\right. \\
&\left.\left.+|\vec{\sigma}|_{1 / 2-\alpha}\right)\right\}
\end{aligned}
$$

Now for $\alpha \leqslant s \leqslant 1,-s \leqslant-\alpha \leqslant n-2[(p-1) / 2]-1 / 2 \leqslant n-1 / 2$ so that $\bar{t}=-s$. Hence for $\alpha \leqslant s \leqslant 1$ and $h \leqslant \varepsilon k^{2(p-\alpha) /(2-\alpha)}$ we get

$$
\begin{aligned}
& \left\|w_{i}(\vec{\sigma})-w_{i}\left(\vec{\sigma}_{k}\right)\right\|_{s} \leqslant C h^{2-s}|\vec{\sigma}|_{1 / 2} \\
& \quad+C h^{2-s} k^{s-\alpha}\left(\|f\|_{-\alpha}+|\vec{\sigma}|_{1 / 2-\alpha}\right)+C\left|\vec{\sigma}-\vec{\sigma}_{k}\right|_{s+2 i-2 p+1 / 2}
\end{aligned}
$$

Noting that for $\alpha \leqslant s \leqslant 1, \alpha \leqslant s+2 i \leqslant 2 p-1$ for $i=0,1, \ldots, p-1$ we get by Theorem 5.3 that

$$
\begin{aligned}
\left|\vec{\sigma}-\vec{\sigma}_{k}\right|_{s+2 i-2 p+1 / 2} \leqslant C\left\{h^{2-\alpha}\right. & k^{\alpha-s-2 i}\left(\|f\|_{-\alpha}+|\vec{\sigma}|_{1 / 2-\alpha}\right) \\
& \left.+k^{\dot{r}-2[(p-1) / 2]-s-2 i+2 p+1 / 2}|\vec{\sigma}|_{\dot{r}-2[(p-1) / 2]}\right\}
\end{aligned}
$$

Combining our results we have for $\alpha \leqslant s \leqslant 1$ and $h \leqslant \varepsilon k^{2(p-\alpha) /(2-\alpha)}$ that
$\left\|\mid w_{i}-w_{h, i}\right\|_{s} \leqslant C\left\{h^{2-s}\left(|\vec{\sigma}|_{1 / 2-s}+\|f\|_{-s}\right)\right.$

$$
\begin{aligned}
& +\left(h^{2-s} k^{s-\alpha}+h^{2-\alpha} k^{\alpha-s-2 i}\right)\left(\|f\|_{-\alpha}+|\vec{\sigma}|_{1 / 2-\alpha}\right) \\
& \left.+k^{\dot{r}-2[(p-1) / 2]-s-2 i+2 p-1 / 2}|\vec{\sigma}|_{\dot{r}-2[(p-1) / 2]}\right\}
\end{aligned}
$$

$i=0,1, \ldots, p-2$.
For $i=p-1$, the estimate holds with $\|f\|_{-s}$ replaced by $\|f\|_{0}$.
Although we will not do so here, we remark that similar arguements can be used to derive estimates in the case $s<\alpha$.

Example 5.3 : $p=2, \dot{r}=2, n=1, h \leqslant \varepsilon k^{2}, s=0, \alpha=0$

$$
\left\|u-u_{h}\right\|_{0} \leqslant C h^{2}\left(\|f\|_{0}+|\vec{\sigma}|_{1 / 2}\right)+C k^{11 / 2}|\vec{\sigma}|_{2}
$$

Choosing $h=C k^{11 / 4}$ we get that $h \leqslant \varepsilon k^{2}$ for $k$ sufficiently small.
Example $5.4: p=2, \dot{r}=1, n=0, h \leqslant \varepsilon k^{2}, s=1, \alpha=1 / 2$

$$
\begin{aligned}
& \left\|u-u_{h}\right\|_{1} \leqslant C\left\{h\left(|\vec{\sigma}|_{-1 / 2}+\|f\|_{-1}\right)\right. \\
& \left.\quad+\left(h k^{1 / 2}+h^{3 / 2} k^{-1 / 2}\right)\left(\|f\|_{-1 / 2}+|\vec{\sigma}|_{0}\right)+k^{7 / 2}|\vec{\sigma}|_{1}\right\}=0(h)+0\left(k^{7 / 2}\right) .
\end{aligned}
$$

## 6. EFFICIENT SOLUTION OF PROBLEM ( $Q_{h}^{k}$ )

In this section we show how some ideas developed in [4] can be extended to develop methods for the efficient solution of the linear systems of equations arising from Problem $\left(Q_{h}^{k}\right)$. To describe these ideas we first define a discrete boundary Laplacian

$$
l_{k}: \dot{S}_{k} \rightarrow \dot{S}_{k} \quad \text { by }\left\langle l_{k} \phi, \theta\right\rangle=\langle\phi, \theta\rangle+\left\langle\phi_{s}, \theta_{s}\right\rangle
$$

where $\phi_{s}$ is the tangential derivative of $\phi$ along $\Gamma$. We note that $l_{k}$ is positive definite and symmetric and hence $l_{k}^{s}$ may be defined in the usual way by taking powers of its eigenvalues.

The method we present depends on the following property of the operator $l_{k}^{s}$ (cf. [5]).

Lemma 6.1 : Let $\dot{S}_{k} \subset H^{1}(\Gamma)$. Then for $-\dot{r} \leqslant s \leqslant 1$, there are constants $C_{1}$ and $C_{2}$ such that for $\phi \in S_{k}$

$$
\begin{equation*}
C_{1}|\phi|_{s}^{2} \leqslant\left|l_{k}^{s / 2} \phi\right|_{o}^{2} \leqslant C_{2}|\phi|_{s}^{2} . \tag{6.1}
\end{equation*}
$$

Combining Lemma (6.1) with Lemma (4.3) we have for $r-2 p \geqslant-1$, $1 \geqslant 1 / 2-p+2[(p-1) / 2] \geqslant-\dot{r}$, and $h \leqslant \varepsilon k$ that

$$
\begin{aligned}
C_{0} \sum_{j=1}^{\left[\frac{p+1}{2}\right]}\left|l_{k}^{1 / 4-p / 2+(j-1)} \sigma_{j}\right|_{0}^{2} & \leqslant\left|\sum_{i=1}^{\left[\frac{p+1}{2}\right]}\left\langle\sigma_{i}, w_{h, i-1}(\vec{\sigma})\right\rangle\right| \\
& \leqslant C_{1} \sum_{j=1}^{\left[\frac{p+1}{2}\right]}\left|l_{k}^{1 / 4-p / 2+(j-1)} \sigma_{j}\right|_{0}^{2}
\end{aligned}
$$

for all $\vec{\sigma} \in \dot{V}_{k}$.

Defining $\lambda_{j}=l_{k}^{1 / 4-p / 2+(j-1)} \sigma_{j}$ and using the equivalence of vector norms and the symmetry of $l_{k}^{s}$ we get

$$
\begin{align*}
C_{0} \sum_{j=1}^{\left[\frac{p+1}{2}\right]}\left|\lambda_{j}\right|_{0}^{2} & \leqslant\left|\sum_{i=1}^{\left[\frac{p+1}{2}\right]}\left\langle l_{k}^{-1 / 4-p / 2+(i-1)} P_{0} w_{h, i-1}(\vec{\sigma}), \lambda_{i}\right\rangle\right| \\
& \leqslant C_{1} \sum_{j=1}^{\left[\frac{p+1}{2}\right]}\left|\lambda_{j}\right|^{2} . \tag{6.2}
\end{align*}
$$

Further defining

$$
Z_{h, i-1}^{k}(\vec{\lambda})=l_{k}^{-1 / 4+p / 2-(i-1)} P_{0} \sum_{j=1}^{\left[\frac{p+1}{2}\right]}(-1)^{p-i-j} T_{h}^{p-j} G_{h} l_{k}^{-1 / 4+p / 2-(j-1)} \lambda_{j}
$$

we have that $Z_{h, i-1}^{k}(\vec{\lambda})=l_{k}^{-1 / 4+p / 2-(i-1)} P_{0} w_{h, i-1}(\vec{\sigma})$ so that (6.2) becomes

$$
\begin{equation*}
C_{0} \sum_{j=1}^{\left[\frac{p+1}{2}\right]}\left|\lambda_{j}\right|_{0}^{2} \leqslant\left|\sum_{i=1}^{\left[\frac{p+1}{2}\right]}\left\langle Z_{h, i-1}^{k}(\vec{\lambda}), \lambda_{i}\right\rangle\right| \leqslant C_{1} \sum_{j=1}^{\left[\frac{p+1}{2}\right]}\left|\lambda_{j}\right|_{0}^{2} \tag{6.3}
\end{equation*}
$$

Hence if instead of solving the system (4.14) we solve the equivalent system

$$
\begin{equation*}
Z_{h, i}^{k}(\vec{\lambda})=l_{k}^{-1 / 4+p / 2-i}(-1)^{p-i+1} T_{h}^{p-i} f, \quad i=0,1, \ldots,[(p-1) / 2] \tag{6.4}
\end{equation*}
$$

then ( 6.3 ) implies that the matrix induced by this system will have a condition number bounded independent of $k$ and $h$. Thus the conjugate gradient algorithm will provide an efficient means to solve (6.4) and to use it we need only be able to compute the action of the operators $T_{h}, G_{h}$ and $l_{k}^{s}$ for appropriate $s$ (cf. [1]). The action of $T_{h}$ and $G_{h}$ are easily computed and so is $l_{k}^{s} v i a$ discrete Fourier transform when $\dot{S}_{k}$ consists of smooth splines on a uniform mesh.

If we wish to avoid the computation of $l_{k}^{s}$ for non-integer powers of $s$ we can also obtain a well conditional system by using Theorem 4.1 with $s=3 / 2$ (provided $n \geqslant 1$ ) and Lemma (6.1).

We then get for

$$
2 p-1 \leqslant \dot{r} \leqslant r-2[(p-1) / 2]-1 / 2+2 p
$$

and $h \leqslant \varepsilon k$, that

$$
\begin{align*}
C_{0} \sum_{j=1}^{\left[\frac{p+1}{2}\right]}\left|l_{k}^{1-p+(j-1)} \sigma_{j}\right|_{0}^{2} & \leqslant \sum_{i=0}^{\left[\frac{p-1}{2}\right]}\left|l_{k}^{1 / 2-i} P_{0} w_{h, i}(\vec{\sigma})\right|_{0}^{2} \\
& \leqslant C_{1} \sum_{j=1}^{\left[\frac{p+1}{2}\right]}\left|l_{k}^{1-p+(j-1)} \sigma_{j}\right|_{0}^{2} \tag{6.5}
\end{align*}
$$

Now set $\lambda_{j}=l_{k}^{1-p+(j-1)} \sigma_{j}$. Then

$$
\begin{aligned}
& {\left[\frac{p-1}{2}\right]} \\
& \sum_{i=0}^{2}\left|l_{k}^{1 / 2-i} P_{0} w_{h, i}(\vec{\sigma})\right|_{0}^{2} \\
& =\sum_{i=0}^{\left[\frac{p-1}{2}\right]}\left\langle l_{k}^{1-2 i} P_{0} w_{h, i}(\vec{\sigma}), P_{0} w_{h, i}(\vec{\sigma})\right\rangle \\
& =\sum_{i=0}^{\left[\frac{p-1}{2}\right]}\left\langle l_{k}^{1-2 i} P_{0} w_{h, i}(\vec{\sigma}), P_{0} \sum_{j=1}^{\left[\frac{p+1}{2}\right]}(-1)^{p-i-j} T_{h}^{p-i-j} G_{h} \sigma_{j}\right\rangle \\
& =\sum_{i=0}^{\left[\frac{p-1}{2}\right]}\left[\frac{p+1}{2}\right] \\
& \sum_{j=1}^{2}(-1)^{p-i-j}\left\langle P_{0} T_{h}^{p-i-j} G_{h} l_{k}^{1-2 i} P_{0} w_{h, i}(\vec{\sigma}), \sigma_{j}\right\rangle \\
& =\sum_{j=1}^{\left.\frac{p+1}{2}\right]}\left[\frac{p-1}{2}\right] \\
& \sum_{i=0}^{2} \\
& \left.(-1)^{p-i-j}\left\langle l_{k}^{-1+p-(j-1}\right) P_{0} T_{h}^{p-i-j} G_{h} l_{k}^{1-2 i} P_{0} w_{h, i}(\vec{\sigma}), \lambda_{j}\right\rangle
\end{aligned}
$$

where we have used Lemma 3.3 and the symmetry of $l_{k}^{s}$.
If we now define $Z_{h, j}^{k}(\vec{\lambda})$

$$
\begin{aligned}
=\sum_{i=0}^{\left[\frac{p-1}{2}\right]}(-1)^{p-i-j} l_{k}^{-1+p-(j-1)} P_{0} T_{h}^{p-i-j} & G_{h} l_{k}^{1-2 i} P_{0} \\
& \times \sum_{m=1}^{\left[\frac{p+1}{2}\right]} T_{h}^{p-i-m} G_{h} l_{k}^{-1+p-(j-1)} \lambda_{j},
\end{aligned}
$$

then

$$
Z_{h, j}^{k}(\vec{\lambda})=\sum_{i=0}^{\left[\frac{p-1}{2}\right]}(-1)^{p-i-j} l_{k}^{-1+p-(j-1)} P_{0} T_{h}^{p-i-j} G_{h} l_{k}^{1-2 i} P_{0} w_{h, i}(\vec{\sigma})
$$

so that (6.5) becomes

$$
\begin{equation*}
C_{0} \sum_{j=1}^{\left[\frac{p+1}{2}\right]}\left|\lambda_{j}\right|_{0}^{2} \leqslant\left|\sum_{j=1}^{\left[\frac{p+1}{2}\right]}\left\langle Z_{h, j}^{k}(\vec{\lambda}), \lambda_{j}\right\rangle\right| \leqslant C_{1} \sum_{j=1}^{\left[\frac{p+1}{2}\right]}\left|\lambda_{j}\right|_{0}^{2} \tag{6.6}
\end{equation*}
$$

Hence if instead of solving the system (4.14) we solve the equivalent system

$$
\begin{array}{r}
Z_{h, j}^{k}(\vec{\lambda})=\sum_{i=0}^{\left[\frac{p-1}{2}\right]}(-1)^{p-i-j} l_{k}^{-1+p-(j-1)} P_{0} T_{h}^{p-i-j} G_{h} l_{k}^{1-2 i} P_{0}(-1)^{p-i+1} T_{h}^{p-i} f \\
j=1,2, \ldots,[(p-1) / 2], \tag{6.7}
\end{array}
$$

then (6.7) implies that the matrix induced by this system is uniformly wellconditioned (independent of $h$ and $k$ ). Once again the system can be efficiently solved using the conjugate gradient method. In this case only the action of $T_{h}, G_{h}$ and integer powers of $l_{k}$ need be computed.
